Tourist & Visiting Requirements:

1. Complete filled up Tourist visa application form Sub class 600
2. Family composition form 54
3. Two (2) passport sized (3.5"X4.5") photographs
4. Evidence of the applicant's Passport and previous travel
 - Current Passport Original Expired Passport Original Copy of e-visa issued
5. Evidence of applicant current employment or self-employment
 - Employment Certificate **showing your tenure, salary, position (if employed)**
 - Business Registration (DTI or SEC) and Business Mayor's Permit (if Business or Self employed)
 - Payslip
 - ITR (2316 or 1701)
 - Approved leave
6. Evidence of applicant intention to return and change of name.
 - PSA Birth Certificate PSA Death Certificate Divorce Decree Absolute
 - Legal Will PSA Marriage Certificate PSA Marriage registration documents
6. Evidence of applicant's financial status
 - Bank Certificate verifying the **current balance of your account(s)**
 - Bank Statement 3 months or copy of updated passbook showing a history of your account(s).
 - Payslip
7. Evidence if visiting a friend in Australia
 - A letter of invitation with a statement indicating the nature of your relationship and details of how, when and where you first met.
 - If you friend paying for your visit, evidence that they have the necessary funds to pay/support for your visit.
 - Bank Certificate Bank Statement Payslip PAYG Payment Summaries
 - Passport readable copy
 - Australian visa if not citizen
8. Evidence if visiting a family/ relatives in Australia.
 - Letter of invitation and statutory declaration** from your relative
 - Evidence that they have the necessary funds to pay/support for your visit.
 - Bank Certificate Bank Statement Payslip PAYG Payment Summaries
 - Passport readable copy
 - Australian visa if not citizen
9. Evidence of applicant's relationship to connect family, relatives and friends in Australia
 - PSA Birth Certificate PSA Marriage Certificate Provide other proof of relationship
10. Evidence family members are travelling with you,
 - PSA Child Birth Certificate PSA Parents Marriage Certificate
11. Evidence if child applicant is student and under the age of 18 years
 - Bank Certificate verifying the **current balance of your account(s)**
 - Form 1229 Consent to grant an Australian visa to a child under the age of 18 years.
 - Form 1257 Undertaking declaration
 - Parents supporting documents same as above.
12. Evidence of planned tourism activities in Australia
 - Planned Activities Hotel booking Flight Itinerary

Additional requirements:

Organised group tours: Covering letter from the tour organizer, including the full itinerary and purpose of the tour, and a list of all participants.

Non-Filipino Nationals: Residing in the Philippines: Evidence of their visa status or residence in the Philippines, including their right to return.

Applicants 75 years old or over: Receipt showing that they have undergone a medical examination from one of the approved panel doctors (after filing, wait for the embassy referral letter) and Travel Insurance which will cover medical expenses for the full stay in Australia.

Applicants intending to visit Australia for more than 3 months (11 years or older): A receipt showing that they have undergone a chest x-ray from one of the approved panel doctors (after filing, wait for the embassy referral letter) and Travel Insurance, which will cover medical expenses for the full stay in Australia. (2.5M or higher coverage policy.)
