- 01. For visa applicants with remarks of late registration on their PSA birth certificate, need to submit the original documents such as:
 - a. Baptismal certificate
 - b. Elementary or High School Form 1-37
- 02. For visa applicants with <u>No Record</u> with PSA, need to secure a **Certificate of No Record Found** issued by the Local Civil Registrar or a live birth certificate issued by the National Archives.
- 03. For visa applicants with <u>unreadable</u> details on their PSA birth certificate and/or PSA issued marriage contract, need to submit a **certified true copy of their birth and/or marriage issued by the Local Civil Registrar.**
- 04. For visa applicants holding professional licenses (i.e., lawyers, engineers, medical professionals), they have the option to submit a printed copy of **IBP ID** or **PRC ID**.
- 05. For student submit copy of school ID.
- 06. We will only accept visa applications with **complete documents**.
- 07. Visa fees and requirements are subject to change without prior notice.
- 08. Once the visa application is filed, your passport will be in the possession of the Embassy, whether locally or internationally. Please ensure that you have no planned travel immediately before, during and immediately after processing.
