<b>Two Way Airline Ticket Reservation (Detailed itinerary) <u>Airline Reservation is acceptable.</u></b> It is strongly recommended not to purchase the flight ticket before obtaining the visa.		✓
<b>Travel Health Insurance</b>		✓
<ul style="list-style-type: none"> <li>o Minimum coverage of 30,000 Euros</li> <li>o Must be recognized in all Schengen States</li> <li>o Valid period of the insurance coverage must be for the duration of the intended stay</li> </ul>		
<b>Proof of Accommodation</b>		
<ul style="list-style-type: none"> <li>o <b>For Tourist:</b> Confirmed Hotel Reservations (for the entire stay in Schengen area)</li> <li>o <b>If Invited by Family/Friend:</b> Invitation letter issued by the Spanish Police, or an invitation letter including the photocopy of the sponsor's passport and/or D.N.I., or residence card and registration of residency ("empadronamiento").</li> </ul>		✓ ✓
<b>For spouses:</b> If spouses of Spanish/EU nationals, marriage contract (issued not more than 6 months before the submission of the application) <u>recognizes by the Government of the corresponding EU national is required.</u> Marriages that are not registered/recognized by the corresponding EU Government will not be processed as an EU spouse visa. Only marriages recognized/registered by the corresponding EU Government are free of charge. <b>The marriage certificate issued by the Filipino authorities (PSA) will have to be submitted duly authenticated by the Department of Foreign Affairs (DFA).</b>		✓
<b>Identity/Marital Status</b>		
<ul style="list-style-type: none"> <li>o <b>If Single:</b> Birth Certificate (<b>For Minors, Original Birth Certificate is required.</b>)</li> <li>o <b>If Married:</b> Birth Certificate and Marriage Contract</li> <li>o <b>For Non - Filipino applicants:</b> Please present your ACR, ICR valid at least three months beyond the date of departure from the territory of the Schengen States (and 1 set of photocopies).</li> </ul>		✓ ✓ ✓
<b>Minors:</b> The corresponding authorization and birth certificate issued by the PSA		
<ul style="list-style-type: none"> <li>o If travelling alone or with only one parent: written consent of the non - travelling parent/legal guardian or proof of sole custody of the travelling parent or legal guardian. If the name of the father does not appear in the PSA issued birth certificate, no consent is required.</li> <li>o Copy of bio data page of parent(s) or legal guardian's passport</li> <li>o If travelling alone: Department of Social Welfare and Development (DSWD) clearance.</li> <li>o Certificate of leave absence if travelling during school year.</li> </ul>	✓	✓ ✓
<b>Valid Passport</b> (with 3 month's validity from the end of intended stay, must contain two empty pages) and Previous passport's (latest 2 old passports)	✓	✓

<b>For non appearance:</b> With previous Schengen visa issued last 3 years. <u>The representative shall provide an authorization letter fully signed (wet signature) by the applicant.</u>	✓
